TAKE NOTICE the land hereinafter described is subject to conditions in relation to a subdivision consent notice as follows:

- (a) Any dwelling erected on the Lots shall no longer be required to be constructed within the building platforms shown on DP 300734
- (c) Prior to the occupation of any dwelling the owner for the time being shall, unless connections are available to a reticulated domestic and fire fighting water supply, install a water tank of a capacity of no less than 23,000 litres, of which 14,000 litres is to remain as a static reserve for fire-fighting purposes. At such time that a dwelling is established, the owner shall undertake amenity planting to mitigate the visual effect of the tanks from other areas external to the site.

AND THAT you are hereby directed and required to register the same pursuant to Section 221 of the Resource Management Act 1991.
